Dear Sir,

I, do hereby lodged a complaint empowered by enabling the Electricity Act 2003 (with Amendment Act 2007) against Sri Rabindranath Singha S/o. Lt. Rakhal Singha of Village: Rajarampur, P.O- Khagda Birgram, P. S. Chandipur, Dist: Purba Medinipur, for commission of theft in respect of electricity u/s 135 of Electricity Act 2003 with Amendment Act 2007 as stated here under.

On dated 29/05/2017 at about 01:20 PM I, Sri Tanmoy Saha, Assistant Engineer and Station Manager, Chandipur CCC, WBSEDCL along with

- 1) Sri. Sankar Kumar Biswas, Sr. SAE, Chandipur Customer Care Centre, WBSEDCL
- 2) Sri. Buddhadeb Parua, HGr Sr LM, Chandipur Customer Care Centre, WBSEDCL
- 3) entered into the agricultural premises of Sri Rabindranath Singha S/O. Lt. Rakhal bearing consumer ID 200906481 and meter no - SX000369, and detected that he was consuming electricity dishonestly by bypassing the energy meter by direct hooking from the nearest LT source for less recording of energy units into the meter for his wrongful gain, causing theft of power and loss of revenue of WBSEDCL at the tune of load 4.70 KVA for agricultural purpose. As theft of Electricity was detected during the inspection, at first the service connection was disconnected and removed the unauthorized wires and there after I seized Some portion of hooking wires 2 numbers single core PVC wire red and green color measured approximately 3 metres in each with hooking portion used for pilferage of electricity. The same was seized under a memo of seizure list in the presence of respective witnesses and their signature also obtained on the seizure list. I also prepared an inspection report in presence of the respective witnesses. The above seized materials were packed and labeled at the inspection site and the signature of the witnesses also obtained on the packet and label. The inspection team left the premises at 01:40 PM.

Thus the above mentioned accused person, Sri Rabindranath Singha S/o. Lt. Rakhal of Village: Rajarampur, P.O- Khagda Birgram, P. S. Chandipur, Dist: Purba Medinipur has committed an offence under section 135(1)(b) of the Electricity Act 2003 (with Amendment Act 2007). Under this circumstances you are requested to take cognizance of this complain and treat the same as FIR against above mentioned person accordingly. The FIR is typed by me.
