Dear Sir,

I, do hereby lodged a written complaint empowered by enabling the Electricity Act 2003 (with Amendment Act 2007) against one Sk. Jamsed Ali, S/O-Lt. Sk. Based, Village+ P. O. Kotbarh, P. S. Chandipur, Dist: Purba Medinipur for commission of theft in respect of electricity u/s 135(1)(a) & (b) of Electricity Act 2003 with Amendment Act 2007 which stated here under.

Today i.e. 29/06/2017 at about 1:45 P.M. I, Sri Tanmoy Saha, Assistant Engineer and Station Manager of Chandipur CCC, WBSEDCL along with Sri. Dipak Sinha, LM, Chandipur CCC and Sri. Madhav Chandra Manna, LM, Purba Medinipur Region Office WBSEDCL and other officials had been to the domestic premises of Sk. Jamsed Ali, S/O-Lt. Sk. Based, Vill. +P. O. Kotbarh for inspection purpose. In course of inspection it was found that Sk. Jamsed Ali has got one meter reference meter no L4078824 and con id- 222143527, instead of that he was consuming electricity unauthorisely by way of directly hooking from the nearest LTOH line and bypassing the energy meter for less recording of energy units into energy meter for bypassing purpose causing loss of revenue of WBSEDCL at the tune of load 0.99 KVA.

As theft of Electricity was detected during inspection, at first I disconnected the service cable and there after I seized some portion of one single core PVC wire of black colour with hooking device attachec (3 metres approx) and one yellow card bearing serial No-239813 in the name of Sk. Jamsed Ali duly signed on it by the witnesses alongwith Sk. Bhola, a representative of the accused. The above seized article was duly packed and labled at the inspection site in presence of the witnesses and their signature was duly obtained on the packet and labled. I also prepared an inspection report at site and duly signed by the witnesses and Sk. Bhola The representative of the accused. After completion of inspection, the team left the aforesaid premises at 2:05 P.M.

Thus the accused Sk. Jamsed, S/O-Lt. Sk. Based Village+ P. O. Kotbarh, P. S. Chandipur, Dist: Purba Medinipur, has committed an offence u/s 135(1)(a) & (b) of the Electricity Act 2003(Read with Amendment Act 2007) for commission of theft in respect of electricity dishonestly.

Under the above circumstances you are requested to take the cognizance of the case and treat the same as FIR. The FIR is typed by me.
