In producing herewith one arrested accused person namely Laxman Bera (42) S/O- Khudiram Bera of Rampur, PO-Attartar, PS- Chandipur, Dist- Purba Medinipur, and the following seized articles under proper seizure list,

I sub Inspector of Police Tapas Kr Das do hereby lodge complaint that on 03.07.17 afternoon I was on duty for Ulta Rath Jatra at Chowkhali with C/407 Sanatan Mandi ,VP Sovan Mishra and civic Volunteers vide Chandipur PS Spl CC No 82/17 dt:03.07.17 and Chandipur PS GDE No 114 dt 03.07.17 . In the evening some youths from Kulapara and Purusuttampur with separate arrangement area came with Huge DJ Box sound system with a high noise creating disturbance in the area at Kulapara Konmochor at about 19.05 hrs . Accordingly I asked them to stop the loud noise of the DJ Box sound system as the same is creating disturbance in public and they had no permission of the same regarding their permission. I also aware them about the recent order promulgated by Hon'ble District Magistrate, Purba Medinipur vide memo No 175/JM Dt 15.06.17. I had also issued notice to the above person, owner/operator of the sound system to abide by the law. I also issued notice to the members of the sound systems and also read over the above mentioned order of Hon'ble District Magistrate, Purba Medinipur. Later some local people requested me to allow the religious possession with a low sound and asked the youth to help police. Considering the religious sentiments and hope of maintain of rule they were allowed to go .Also there was a less force and in this situation a huge L/O may occur to seize sound system I took the step as legal action may be taken against them later. After that at about 22.35 hrs I received information from O/C Chandipur PS that one Parimal Das of Kulapara*, Khdhya Karmadhakhya of Chandipur Panchayet Samity had called at PS and informed that the sound systems are again started loudly and the youths under influence of liquor are creating disturbance again. I informed O/C regarding the previous action and asked for reinforcement as action with less force may be dangerous for our life. As per order of O/C , SI Arun Pati with force and ASI Arun Acharjya with force vide CC NO 2273/17 , 2274/17, 2277/17, 2278/17, who was already deputed for mobile duty and force deputed in other places reached at Chowkhali at about 23.05 hrs. After reinforcement I went to Kulapara Konmochor. Showing police all the miscreants leave the place. I tried to seize all the equipments of the DJ Box system. But none was found to move the huge boxes of the sound system. Also it was bounded in a mechanized van and none came forward to drive the same. Finding no other alternatives I seized the moveable equipments of the system so that I can carry in our police van. At that time we also heard the sound of the DJ Box sound system. The above persons also were not helpful to police to move the huge sound system box and dined to help police. It was necessary to arrest him as he had committed offence U/S 188/187/186/291 IPC and 32/34 Police Act in

presence of police officer. During arrest he was informed about his arrest. Later on interrogation he disclosed that Khudiram Bera S/O- Surendranath of Rampur, PO- Attartar, PS- Chandipur, Dist- Purba Medinipur is also owner of Jayashri Sound, Rampur, Jhowtata, the trade name of seized sound system.



After that went to Purusuttampur village under GP-I, to search the DJ Box system. On police arrival the miscreants left the place keeping the sound system in a narrow way that ordinarily it was not possible to move also live wire was there. On being asked only some females of the village came forward and asked for mercy of offence of their child and man. However after a prolonged conversation none came out to move the sound system to PS. As there was none among us to remove the huge system from the narrow road and moving of same without expert may cause any accident or electrification and none will be ready to move it in the dead night, so I decided not to bring the same. On local enquiry it was learnt that the owner/operator of the DJ Box sound system was Sankar Maity S/O- Kritibas Jana of Fotepur, PS- Bhagbanpur and the arranger of the possession with the said DJ Box sound system was Arabinda Ghorai S/O- Lt Anil, Rudra Ghorai S/O- Anil, Sanatan Bera S/O- Prabhas Bera, Nandadulal Ghorai S/O Lt. Bhogirath, Sankar Ghorai S/O- Lt Sudhir, Biswajit Ghorai S/O- Lt Niranjan, Sambhu Ghorai S/O- Lt Anil, Sanjay Ghorai S/O- Tarapada, Chandan Ghorai S/O- Dukhubala Ghorai all of Purusuttampur, PS- Chandipur, Dist- Purba Medinipur, Chandan Sahoo S/O- Subal of Gorberia, PS- Chandipur, Dist- Purba Medinipur (driver/owner of mechanized engine van carrying the system). I had verified the involvement of them with the local village police and civic volunteers and on my personal source of the area.

Therefore I hereby lodge complaint against the arrested accused person namely (1) Laxman Bera (42) S/O- Khudiram Bera of Rampur, PO-Attartar, PS- Chandipur, Dist- Purba Medinipur (owner/operator of seized sound system) and involved accused namely (2) Sankar Maity S/O- Kritibas Jana of Fotepur, PS- Bhagbanpur, Dist- Purba Medinipur (owner/operator of the another DJ Box sound system) and the arranger of the possession with the said DJ Box sound system namely (3) Arabinda Ghorai S/O- Lt Anil, (4) Rudra Ghorai S/O- Anil, (5) Sanatan Bera S/O- Prabhas Bera, (6) Nandadulal Ghorai S/O Lt. Bhogirath, (7) Sankar Ghorai S/O- Lt Sudhir, (8) Biswajit Ghorai S/O- Lt Niranjan, (9) Sambhu Ghorai S/O- Lt Anil, (10) Sanjay Ghorai S/O- Tarapada, (11) Chandan Ghorai S/O- Dukhubala Ghorai all of Purusuttampur, PS- Chandipur, Dist- Purba Medinipur and (12) Khudiram Bera S/O- Surendranath of Rampur, PO-Attartar, PS- Chandipur, Dist- Purba Medinipur (Owner of Jayashri Sound, the trade name of seized sound system), (13) Chandan Sahoo S/O- Subal of Gorberia, PS- Chandipur, Dist- Purba Medinipur (driver/owner of mechanized engine van carrying the system) and 200/250 others of Kulapara and Purusuttampur and nearby who were in the possession and involved in the offence for their involvement in offence punishable U/S 188/187/186/291 IPC and 32/34 Police Act and pray for starting a case for investigation.
