Sir,

In producing herewith arrested accused namely Khokan Mondal (38) S/O Saktipada Mondal, of Vill- Junparia P.S. Chandipur, Dist. Purba Medinipur along with seized following articles. I, SI Dibakar Dolui of Chandipur PS submit a written complaint to the effect that On 17.02.17 at about 17.35 hrs while myself along with force were engaged in evening mobile duty, then I received an information that one Khokan Mondal (38) S/O Saktipada Mondal, of Vill- Junparia P.S. Chandipur, Dist. Purba Medinipur is selling with country spirit in his stationary shop at Junparia under Chandipur P.S. After receiving the said information I informed to O/C Chandipur PS. As per order by O/C Chandipur PS myself along with force reached at Junparia, and arrived at 18.05 hrs. After arrival I found above noted person is selling with country spirit in his stationary shop at Junparia under Chandipur P.S. I called local public to assist police for their presence during search but they did not agree. Seeing the police party the above noted person tried to flee away but myself with force managed to intercept him. On interrogation said Khokan Mondal confessed his guilt and on demand he failed to produce any valid License or valid documents in respect of selling country spirit. So I arrested him U/S 46A (c) of B E Act 1909 Inform him the ground of arrest by issuing memo of arrest and as shown by the aced. I recovered 12 country spirit (Mark of Sun fighter) bottles. I seized the 12 country spirit bottles each 600 ml from the possession of the accused Khokan Mondal and 1(One) 600 ml bottle country spirit taken (Mark of Sun fighter) as sample in presence of witnesses. Then I prepared seizure list and labeled such articles which is duly signed by witnesses and aced Khokan Mondal (38) S/O Saktipada Mondal, of Vill- Junparia P.S. Chandipur, Dist. Purba Medinipur Total amount Rs-12X55 Ltrs= Rs. 660/-.

So I beg to pray that a case U/S 46A(c) of BE Act.1909 may kindly be started against the aced. Khokan Mondal (38) S/O Saktipada Mondal, of Vill- Junparia P.S. Chandipur, Dist. Purba Medinipur.
