Sir,

In producing herewith arrested accused Tapan Maity (40 Yrs)@Khora S/O Lt. Kanai Maity of Vill- Boroj, P.S.- Chandipur, Dist- Purba Medinipur. I S.I Badal Nayak of Chandipur PS submit a written complaint to the effect that today on 28.12.16 at about 17.35 hrs while myself along with force & L/C 427 Rabison Khatun were engaged in evening petrol duty at Chandipur P.S area. I received an information that one Tapan Maity (40 Yrs)@Khora S/O Lt. Kanai Maity of Vill- Boroj, P.S.- Chandipur, Dist- Purba Medinipur is selling with I.D. liquor at Boroj Bazar. After receiving the said information I informed to O/C Chandipur PS. As per order by O/C Chandipur PS myself along with force & L/C reached at Boroj Bazar and arrived at 18.05 hrs. After arrival I found above noted person is selling with I D Liquor at Boroj Bazar in his tea-cum Tiffin Shop. I called local public to assist police for their presence during search but they did not agree. Seeing the police party the above noted person tried to fled away but myself with force managed to intercept him. On interrogation said Tapan Maity (40 Yrs)@Khora confessed his guilt and on demand he failed to produce any valid License or valid documents in respect of selling ID Liquor. So I arrested him U/S 46A (c) of B E Act 1909 Inform him the ground of arrest by issuing memo of arrest and as shown by the aced. I recovered 06 country spirit bottles each 600 ml. I seized the 06 country spirit bottles each 600 ml from the possession of the accused Tapan Maity (40 Yrs)@Khora and 1(One) 600 ml bottle country spirit taken as sample in presence of witnesses. Then I prepared seizure list and labeled such articles which is duly signed by witnesses and aced Tapan Maity (40 Yrs)@Khora S/O Lt. Kanai Maity of Vill- Boroj, P.S.- Chandipur, Dist- Purba Medinipur Total amount Rs-06XRrs.55/- = Rs. 330/-.

So I beg to pray that a case U/S 46A(c) of BE Act.1909 may kindly be started against the aced Tapan Maity (40Yrs)@Khora S/O Lt. Kanai Maity of Vill- Boroj, P.S.- Chandipur, Dist- Purba Medinipur and arrange to investigation by another I.O.
