Sir,

In producing herewith arrested accused Smt. Sabita Maity (35 Yrs) W/O Mahadeb Maity of Vill- Khagda Birgram, P.S.- Chandipur, Dist- Purba Medinipur. I S.I Tapas Kr. Das of Chandipur PS submit a written complaint to the effect that today on 17.03.17 at about 16.35 hrs while myself along with force with L/C 1460 Riktaran Nesha were engaged in evening mobile duty at Chandipur P.S area. I received an information that one Smt. Sabita Maity (35 Yrs) W/O Mahadeb Maity of Vill- Khagda Birgram, P.S.- Chandipur, Dist- Purba Medinipur is selling with ID Liquor at Narghat near Star Bhata. After receiving the said information I informed to O/C Chandipur PS. As per order by O/C Chandipur PS myself along with force with L/C reached at Narghat near Star Bhata and arrived at 17.05 hrs. After arrival I found above noted lady person is selling with country spirit at Narghat near Star Bhata. I called local public to assist police for their presence during search but they did not agree. Seeing the police party the above noted lady person tried to flee away but myself with force with L/C managed to intercept her. On interrogation said Smt. Sabita Maity confessed her guilt and on demand she failed to produce any valid License or valid documents in respect of selling country spirit. So I arrested her U/S 46A (c) of B E Act 1909 Inform her the ground of arrest by issuing memo of arrest and as shown by the accused I recovered 08 country spirit bottles each 600 ml. I seized the 08 country spirit bottles each 600 ml from the possession of the accused Smt. Sabita Maity and 1(One) 600 ml bottle country spirit taken as sample in presence of witnesses. Then I prepared seizure list and labeled such articles which is duly signed by witnesses and accd Smt. Sabita Maity (35 Yrs) W/O Mahadeb Maity of Vill- Khagda Birgram, P.S.- Chandipur, Dist- Purba Medinipur Total amount Rs. 08XRs.55/- = Rs. 440/-.

So, I beg to pray that a case U/S 46A(c) of BE Act.1909 may kindly be started against the accd Smt. Sabita Maity (35 Yrs) W/O Mahadeb Maity of Vill- Khagda Birgram, P.S.- Chandipur, Dist- Purba Medinipur and arrange to investigation by another I.O.
