Sir,

In producing herewith arrested accused 1) Sk Sahalam (36 Yrs) S/O Sk Unish of Vill- Atattar and 2) Narayan Manna (39 Year) S/O Lt Sudhangshu Manna of vill Atattar both of P.S.- Chandipur, Dist- Purba Medinipur along with seized following articles, I SI Badal Nayak of Chandipur PS do hereby lodge complaint to the effect that today on 06.04.17 morning I along with C/ 1634 Sujit Bar, C/ 652 Ganesh Ch Mahato vide CC No 1316/17 dt 06.04.17 was performing morning mobile duty. At about 12.15 hrs during morning mobile duty, I received an source information that two person were carrying Liquor by a Hero Honda Passion Plus Motor cycle bearing no WB 30E/5752 for sell at Attattar and going towards Boroj Bazar from Norghat side. After receiving the said information I informed to O/C Chandipur PS and as per order by O/C Chandipur PS I along with force reached near Boroj Bazar and arrived at 12.30 hrs. After arrival near Boroj Bazar I found two persons are carrying a plastic bag by Motor cycle no WB 30E/5752. Seeing the police party the above noted accused persons tried to flee away but I with force managed to intercept them at Baroj Bazar. I called local public to assist police for their presence during search but they did not agree. On interrogation accused persons disclosed their name and identity noted above and they confessed guilt and opening the plastic bag found a cartoon with liquor. On asked the accused persons failed to produce any valid License or valid documents in respect of carrying / possessing such huge country spirit. They stated that they are carrying the country spirit for selling. I arrested the above accused persons U/S 46A (c) of B E Act 1909 and inform them the ground of arrest by issuing memo of arrest. I also seized the following articles from the possession of accused persons in presence of witness after preparing seizure list duly signed by witness and accused persons.

1. 20(Twenty) Bottle country spirit (Sold 7000) each of 600 ml.
2. 1(One) Bottle country spirit (Sold 7000) of 600 ml collected from seized articles SI. No 01 as sample.
- Total value of seized liquor is Rs. 20XR5.55/- = Rs. 1100/-.
3. One brown color old Hero Honda Passion Plus Motor cycle bearing no WB 30E/5752

So, I beg to pray that a case U/S 46A(c) of BE Act.1909 may kindly be started against the aced 1) Sk Sahalam (36 Yrs) S/O Sk Unish of Vill- Atattar 2) Narayan Manna (39 Year) S/O Lt Sudhangshu Manna of vill Atattar both of P.S.- Chandipur, Dist- Purba Medinipur for investigation.
