Dear Sir,

I, do hereby lodge a complaint empowered by enabling the Electricity Act 2003 (with Amendment Act 2007) to the effect that Sri Pulin Behari Das S/o. Lt. Sasibhusan Das Village: Dhusia P. S. Chandipur, Dist: Purba Medinipur, has committed an offence of theft of electricity u/s 135 of Electricity Act 2003 with Amendment Act 2007 as stated here under.

On dated 17/04/2017 at about 2:20 PM I, Sri Dibyendu Sekhar Bhunia, Divisional Engineer S&LP, Regional Office, Purba Medinipur, WBSEDCL along with

1) Sri. Sankar Kr. Biswas, Sr. SAE(E), Chandipur Customer Care Centre, WBSEDCL

2) Sri. Buddhadeb Parua, Hg Sr LM &

3) Harekrishna Das, Hg Sr LM had been to the village Dhusia for raid and inspection purpose. At first we entered into the house of Sri Pulin Behari Das S/o. Lt. Sasibhusan Das bearing consumer ID 222081483, and Meter NO-H501577 and detected that he was consuming electricity dishonestly by bypassing the energy meter by direct hooking from L.T OH line for less recording of energy to energy meter causing loss of revenue of WBSEDCL. As per physical inspection the assessed load found 1 KVA for Domestic purpose..

As theft of Electricity was detected during the inspection, the service connection was disconnected and removed the unauthorized wire from LT mains thereafter. Some portion of hooking wire, one single core PVC wire black colour with hooking device of length approx 3 metres and one yellow card bearing serial No-628016 in the name of Pulin Behari Das used for bypass of the meter and pilferage of electricity and the same seized under a memo of seizure list in the presence of respective witnesses and their signature also obtained on the seizure list. The above seized materials were packed and labeled at the inspection site and the signature of the witnesses also obtained on the packet and label. I prepare an inspection report at site duly signed by the witnesses on it. I also approached to the accused/representative to sign on the seizure list and inspection report but refused to sign on it. We left the premises after completion of all formalities at 2:45 p.m.

Thus the above mentioned accused person, Pulin Behari Das S/o. Lt. Sasibhusan Das Village: Dhusia P. S. Chandipur, Dist: Purba Medinipur, has committed an offence under section 135(1)(b) of the Electricity Act 2003 (with Amendment Act 2007) in view of theft of electricity.

Under this circumstances you are requested to take cognizance of this complain and treat the same as FIR.
