As theft of Electricity was detected during the inspection, the service connection was disconnected and removed the unauthorized wire from LT mains thereafter Some portion of hooking wire, one single core PVCwire black colour with hooking device of length approx 3 metres and one yellow card bearing serial No-628016 in the name of Pulin Behari Das used for bypass of the meter and pilferage of electricity and the same seized under a memo of seizure list in the presence of respective witnesses and their signature also obtained on the seizure list. The above seized materials were packed and labeled at the inspection site and the signature of the witnesses also obtained on the packet and label.
