Sir,

In producing herewith arrested accused namely Jalpana Pramanik (33Yrs) W/O Arun Pramanik of Vill- Barbanksi, P.S. Chandipur, Dist-Purba Medinipur along with seized following articles. I, SI Badal Nayak of Chandipur PS submit a written complaint to the effect that on 05.05.17 at about 16.00 hrs while myself along with force with L/HG Pratima Maity were engaged in evening mobile duty & spl. Raid duty at Kalikakhali, then I received an information that one Jalpana Pramanik (33Yrs) W/O Arun Pramanik of Vill- Barbanksi, P.S. Chandipur, Dist. Purba Medinipur is carrying country spirit in a carry bag at Chandipur near Chandipur Pry. School under Chandipur P.S. After receiving the said information I informed to O/C Chandipur PS and as per order by O/C Chandipur PS myself along with force with L/HG Pratima Maity had been to Chandipur near Chandipur Pry. School, and arrived at 16.10 hrs. After arrival I found above noted lady person is carrying country spirit in a carry bag at Chandipur near Chandipur Pry. School under Chandipur P.S. I called local public to assist police for their presence during search and one Ashok Sahoo S/O Nanda Kishor Sahoo of Gourchak,PS.- Chandipur,Dist- Purba Medinipur who was going at that place agree to present. Seeing the police party the above noted lady person tried to flee away but myself with force & LHG managed to intercept her. On check found that the above lady carrying one carton 20 (Twenty) bottles country spirit (sun fighter spirit). On interrogation said Jalpana Pramanik disclosed her name and identity and stated that she carrying the country spirit for selling in her village. On demand of police the accused Jalpana Pramanik failed to produced any license or Challan about possessing the above amount of country spirit. On demand she failed to produce any valid License or valid documents in respect of carrying country spirit. So I seized the following 20(Twenty) bottles country spirit (Sun fighter spirit) each 600 ml in a carton box value Rs. 65X20=1300/- from the possession of the accused Jalpana Pramanik after preparing proper seizure list duly signed by witnesses and accused Jalpana Pramanik and 1(One) 600 ml bottle country spirit taken from seized 20 (Twenty) bottles of country spirit as sample. Thereafter I arrested the accused Jalpana Pramanik U/S 46A (c) of B E Act 1909 for possessing / carrying country spirit without license or permission or authority and informed her the ground of arrest by issuing memo of arrest.

So, I beg to pray that a case U/S 46A(c) of BE Act.1909 may kindly be started against the accused Jalpana Pramanik (33Yrs) W/O Arun Pramanik of Vill- Barbanksi, P.S. Chandipur, Dist-Purba Medinipur.
