Sir,

In producing herewith arrested accused namely Srikanta Shit (52 Yrs) S/O Lt. Ananta Shit of Vill- Gopinathpur, P.S. Bhagawanpur, Dist-Purba Medinipur along with seized following articles. I, ASI Momjed Uddin Ahmed of Chandipur PS submit a written complaint to the effect that on 10.05.17 at about 10.55 hrs while myself along with force were engaged in morning mobile duty at Chandipur PS area, then I received an information that one Srikanta Shit (52 Yrs) S/O Lt. Ananta Shit of Vill- Gopinathpur, P.S. Bhagawanpur, Dist-Purba Medinipur is selling country spirit in at Buraburi Mohon Chowdhurychak Khalpar near Tangrakhali under Chandipur P.S. After receiving the said information I informed to O/C Chandipur PS and as per order by O/C Chandipur PS myself along with force had been to Buraburi Mohon Chowdhurychak Khalpar near Tangrakhali, and arrived at 11.50 hrs. After arrival I found above noted person is selling country spirit at Buraburi Mohon Chowdhurychak Khalpar near Tangrakhali under Chandipur P.S. I called local public to assist police for their presence during search but they did not agree. Seeing the police party the above noted person tried to flee away but myself with force managed to intercept him. On check found that the above accused person selling 19(Nineteen) bottles country spirit. On interrogation said Srikanta Shit confessed his guilt and on demand he failed to produce any valid License or valid documents in respect of selling country spirit. So I seized the following 19(Nineteen) bottles country spirit each 600 ml value Rs. 65X19=1235/- from the possession of the accused Srikanta Shit after preparing proper seizure list duly signed by witnesses and accused Srikanta Shit and 1(One) 600 ml bottle country spirit taken from seized 19(Nineteen) bottles of country spirit as sample. Thereafter I arrested the accused Srikanta Shit U/S 46A (c) of B E Act 1909 for selling country spirit without license or permission or authority and informed her the ground of arrest by issuing memo of arrest.

So, I beg to pray that a case U/S 46A(c) of BE Act.1909 may kindly be started against the accused Srikanta Shit (52 Yrs) S/O Lt. Ananta Shit of Vill- Gopinathpur, P.S. Bhagawanpur, Dist-Purba Medinipur.
