In producing herewith arrested accused person namely Bibhang Robi Das (22Yrs) driver of Truck No.- WB 45/3114 S/O Lohari Robi Das of Vill- Mukleshpur, P.S.- Murarai, Dist- Birbhum and seized articles i) One Ten Wheeler Truck Registration No.- WB 45/3114, ii) Insurance Certificate of vehicle registration No.- WB 57. Chassis No./Engine No.- MB1KADYD9CPBU3143/ CBPZ122276 of New India Assurance Co. Ltd. Policy No.- 51290031160100036699 Valid from 08.11.16 to 07.11.17, iii) One D/L (Forged D/L) No.- WB 53-853559 Dated 30.07.08 issued by Licensing Authority, Birbhum in the name of Bibhang Robi Das S/O Lohari Robi Das of Vill- Mukleshpur, P.S.- Murarai, Dist- Birbhum valid up to 29.07.17.

I SI, Badal Nayak of Chanduipur PS do hereby lodge complaint to the effect that I along with C/ 1634 Sujit Bar ,HG Khokan Pramanik was engaged in morning mobile duty vide Chandipur PS C.C. No.- 1689 Dared 11.05.17 and GDE No.- 381 Dated 11.05.17. During mobile duty I was performed naka checking at Chandipur Bazar near Monihar Cinema Hall as per order of O/C Chandipur PS for MV prosecution. During checking at about 13.05 hrs found one Ten Wheeler Truck Bearing No.- WB 45/3114 is coming from Contai side towards Tamluk I stop the vehicle and asked to driver for papers. But the driver failed to produce registration certificate of the vehicle or any authority latter from register owner to drive the vehicle. He also produced a insurance certificate of vehicle bearing No.- WB 57 (Next digits are not noted in certificate). Later on demand he produced a D/L said to be issued by Licensing Authority, Birbhum. On careful checking the D/L it is found that it is a forged D/L. On interrogation the accused driver confessed that he has no D/L issued by any Licensing Authority. He had fraudulently made the same to screen him from legal action with a view to cheat the appropriate authority. From the papers and suspicious behaviors of the above driver it appear that the vehicle may be a stolen vehicle. He even does not inform about the owner of vehicle. From the above circumstances it was necessary to arrest the driver or he may abscond. Accordingly I arrested the above accused driver for offence U/S 471/379/411 IPC & 181 MV Act. I seized the vehicle and the papers produced by the accused driver under seizure list. During arrest the accused was informed the about the ground of his arrest.

So, I hereby lodge complaint against Bibhang Robi Das (22Yrs) driver of Truck No.- WB 45/3114 S/O Lohari Robi Das of Vill- Mukleshpur, P.S.- Murarai, Dist- Birbhum for his involvement in crime punishable U/S 471/379/411 IPC & 181 MV Act and pray to start a case for investigation.
