A patient (Swapan Maity, Vill.-Rampur, P.O.-Nandapur, P.S.-Chandipur) attended the emergency of Erashal B.P.H.C. at 9.20 P.M. on 23.03.2017 due to snake bite. He was attended by me immediately. He was given necessary treatment and kept in observation.

But about 10.45 P.M., a patient party (Purnend Das, of Vill.-Kadamtala, P.O.-Kandaprasra, P.S.-Chandipur) came to the emergency in a drunken condition. He was constantly using offensive language. When I tried to pacify him he attack me physically and threw a fist on my chest.
