Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Manik Manna, S/O - Shubhas Chandra Manna, a permanent resident of Vill-Uttar Tedubi, P.O -Dhandhlibar, P.S -Contai, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 05.04.2017 at about 03.00 PM I, Sri Moumit Maji, A.E & SM Contai CCC along with Sri Sukhdeb Maity, LM, Contai CCC, Sri Swapan Kumar Mondal, Higher Grade TSH, Contai CCC had been to the village- Uttar Tedubi for routine inspection purpose. During inspection it was found that Sri Manik Manna was consuming electricity dishonestly in his Commercial(Fishery) premises consuming electricity unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 1.00 KVA.

As theft of electricity was detected during inspection some portion of single core red coloured PVC coated 1100/660V grade, 10 sq mm aluminium conductor of length 5mtr approx alongwith hooking arrangement has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Manik Manna acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 04.00 PM.

Thus the accused Sri Manik Manna, S/O - Shubhas Chandra Manna, Vill - Uttar Tedubi, P.O -Dhandhlibar, P.S -Contai, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain & treat it as FIR. The F.I.R is typed by me.
