I, Sri Sujoy Byapari BL&LRO do hereby inform you that Sri Nisikanta Maity S/o of Asutosh Maity vill Badalpur P.O-Uttar Badalpur Dist. Purba Medinipore has caused change in the area, character and mode of use of land in plot no 347,348,349,361 of mouza- Jangipur J.L no- 96 P.S Contai un-authorisedly without any prior permission of the Collector and in violation of the provision of Sec 4C of the WBLR Act.

The aforesaid Sri Nisikanta Maity S/o Asutosh Maity therefore has committed an offence which is cognizable and non- bailable and punishable with imprisonment for a term which may extend to three years or with fine which may extend to fifty thousand rupees or with both according to section 4D of WBLR Act.
