This is to inform you that Sri Sourindra Mohan Jana, contesting candidate of BJP has violated the ECI guidelines on 01.04.2017 vis-a-vis commission's instruction letter no. 464/INST/2014/EPS dtd. 10.04.2014 by engaging about 20 motorcycles in a rally from Ghatua to Sabajput & for this act of his, a show-cause letter was served upon him vide memo. no. 214/Elec, Dtd. 02.04.2017 of this office directing him, therein, to show-cause within 24 hours of that notice as to why legal action should not be taken against him as per prescribed provisions of law but no reply has been received by this office till date. Hence, you are requested to initiate a case against him under section 171H of IPC and section 188 of IPC.
