Sir,

I do hereby lodge a complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that Arabinda Kumar Jana , S/O: Lt. Achintya Jana at village: Tentulmuri, P.S.: Contai, Dist: Purba Medinipur has committed theft of electricity U/S-135 of the Electricity Act-2003 read with amendment act-2007 is being stated hereunder.

On 11.04.2017 around 03:20 P.M. I, Subhendu Sarkar, A.E. & Station Manager of Marishda CCC along with Snehasish Khatua, Sr.SAE, Ashok Kr. Dolui, Hg, Sr. LM, Prasun Das, OE and Nabakumar Pramanik, Hg, Sr. TSH belong to Marishda CCC entered the STW premises of Arabinda Kumar Jana . S/O: Lt. Achintya Jana at village: Tentulmuri, P.S.: Contai, Dist: Purba Medinipur for routine inspection and found that Arabinda Kumar Jana , S/O: Lt. Achintya Jana at village: Tentulmuri, P.S.: Contai, Dist: Purba Medinipur was consuming electricity dishonestly by the way of direct hooking for less recording of meter, Causing loss of revenue of WBSEDL at a tune of load 5.88 KVA. There was a STW connection vide Consumer ID: 223029409.

As theft was detected during inspection the service connection of the said consumer has been disconnected from pole side and some portion of single core black, blue & white coated PVC cable were seized in presence of the members of inspection team. The seizure list was prepared in presence of inspection team and obtained signature on the seizure list. The seized material duly packed and labeled. After completion of inspection the inspection team left the aforesaid premises around 03:40 P.M.

Thus Arabinda Kumar Jana , S/O: Lt. Achintya Jana at village: Tentulmuri, P.S.: Contai, Dist: Purba Medinipur have committed theft of electricity U/S - 135 (i)(b) of the Electricity Act 2003 read with amendment act 2007.

You are, therefore, requested to take cognizance of this offence for this complaint and treat it as F.I.R.
