Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Srihari Mondal, S/O - Lt. Sasadhar Mondal, a permanent resident of Vill & P.O -Sofiabad, P.S -Contai, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 08.05.2017 at about 01.00 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty SO, both are of (S&LP), Contai Division Office along with Sri Moumit Maji, AE & SM Contai CCC, Sri Souvik Karar, O.E Contai CCC and others had been to the village-Sofiabad for routine inspection purpose. During inspection it was found that Sri Srihari Mondal was consuming electricity dishonestly in his Commercial fishery premises unauthorisedly by way of direct hooking through 2 nos single core black coloured PVC coated 10 sq mm copper conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.88 KVA.

As theft of electricity was detected during inspection some portion 2 nos single core black coloured PVC coated grade 10 sq mm copper conductor of length 4 mtr each approx along with hooking device were seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Smt. Snehalata Mandal W/O- Srikrishan Mondal (representative of accused, i.e. sister-in-law / boudi of Sri Srihari Mondal) acknowledged the same by putting her signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01.30 PM.

Thus the accused Sri Srihari Mondal, S/O - Lt. Sasadhar Mondal, Vill - Sofiabad, P.O -Sofiabad, , P.S -Contai, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain & treat it as FIR.
