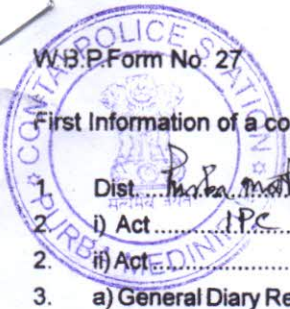

Sir,

I would like to inform you that, today on  
15.5.2017 at 2:25 pm. one patient Nuro Matrammad,  
8/0-8K. Jobed Ali of Swemula, Fuleswar, P.S.-  
Contai, Purbas Medinipur; was admitted at this  
Hospital, sustaining accidental multiple life  
threatening injuries including head injuries.  
The Emergency M.O. started treatment immediately  
on admission and also the surgeon on-duty  
attended the patient within few minutes.

Unfortunately, the patient expired  
on the same day at 3-40 pm. Thereafter, patient  
party and accompanying persons complained of  
negligence in treatment, got agitated and  
broke some hospital furniture, window  
panes and tabletop glasses at emergency dept.

This has caused damages of Govt.  
property and spread panic amongs hospital  
staffs and patients.

Please, take necessary action in  
this regard and treat this as an F.I.R.
