In producing herewith the following seized articles I beg to submit that on 16.05.17 at 08:00 hrs. myself along with force C/824 Madan Mohan Das and C/867 Surajit Dutta while performing Morning Mobile Duty vide C.C. No.-1851/17 dtd. 16.05.17 then received an information that one person namely Laxmikanta Mahara running illegal business of Country Spirit at Namaldiha Bazar. Accordingly I informed I.C Contai PS regarding the matter and as per his direction myself along with force transit towards Namaldiha Bazar to work out the information. On reaching over there I found one shop situated at Namaldiha Bazar and some persons are there on the road side, seeing the police persons the shopkeeper along with other 2/3 persons fled away then I asked the local people to be present and to assist us for searching of the shop. I have searched the said shop in presence of local witnesses and seized the following articles duly signed by the witnesses. On being asked it came to know that one Laxmi Kanta Mahara S/O Atul Mahara of Namaldiha PS-Contai, Dist- Purba Medinipur used to run his illegal business through selling ID Liquors, Country Spirit e.t.c without having any valid license.

- 1) 50 bottles sealed "Sun" Country Spirits each bottles 600 ml.  
600x50 = 3000 ml. valued of Rs. 65x50 = Rs. 3250/-
- 2) 25 Ltrs. ID Liquors
