In producing here with arrested alleged person namely Manas Pramanik (45) S/o.- Lt. Mrihit Pramanik of Bockshipur, Ps. - Junput Coastal, Dist.- Purba Medinipur with 08 bottles sealed Country spirit @ Rs.-65/- each, Total value Rs.- 520/-

I SI Ravi Grahikar, presently posted at Contai Ps. do hereby lodged a complaint as Suo-moto to the effect that on 26.05.17 in course of my evening patrolling duty with C/1172 Mukunda Das & C/1272 Sibram Hembram under Ps. area, at about 20:25 hrs. I received a telephonic information from reliable sources that one person namely Manas Pramanik S/o.- Lt. Mrihit Pramanik of Bockshipur, Ps. - Junput Coastal, Dist.- Purba Medinipur was selling liquors near Soulamore under Contai Ps. since few years.

Accordingly, I inform to I/C Contai Ps. and as per his direction myself along with force reached at Soulamore under Contai Ps. at about 20:45 hrs. and found that said alleged selling Liquors in open place to among to some public illegally. On being searched, 08 bottles Country Spirit in one nylon bag were recovered from his possession. On being asked, he could not produce any valid documents in favour of those liquors. There after, I seized the same under proper seizure list duly signed by the witnesses. I arrested him and during interrogation, it reveals that the alleged Manas Pramanik S/o.-Lt. Mrihit Pramanik was selling liquors from there since few years.

Under the above fact and circumstances, I therefore pray that a case may kindly be started U/S- 46(A) B.E. Act. against said Manas Pramanik (45) S/o.- Lt. Mrihit Pramanik of Bockshipur, Ps. - Junput Coastal, Dist.- Purba Medinipur.
