Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Kalipada Maity, S/O - Lt. Baikuntha Maity, a permanent resident of Vill- & P.O -Basantia, P.S -Contai, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 11.01.2017 at about 12.30 PM I, Sri Moumit Maji, A.E & SM Contai CCC along with Sri Manas Maity, AE (U), Sri Pradip Kr. Chakraborty, SO both are of S&LP wing of Contai Division Office and Sri Sukhdeb Maity, LM Contai CCC, Sri Souvik Karar, O.E Contai CCC had been to the village- Basantia for routine inspection purpose. During inspection it was found that Sri Kalipada Maity was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.7 KVA.

As theft of electricity was detected during inspection the illegal hooking was disconnected & removed from our LTOH line and some portion of two core 4 (four) Sq. mm having black coloured PVC coated cable approximate length 3 meter with hooking device has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Himangshu Maity S/O- Sri Kalipada Maity acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01.00 PM.

Thus the accused Sri Kalipada Maity, S/O - Lt. Baikuntha Maity, Vill - Basantia, P.O -Basantia, , P.S -Contai, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complaint & treating it as FIR. The F.I.R is typed by me.
