Sir,

In producing herewith one arrested accused Kajari Giri (66 yo) Sp-At. Suarata Giri of Athidageri, P.O+PS - Contai, Dist - Purba Medinipur along with seized motor cycle bearing Regd. No WB32A/7254 and all relevant papers in respect of arrest and seizure before your good self for taking necessary legal action. I beg to submit before that on 02/06/2017 kind order of I/C Contai P.S. myself along with CP172 Markunda Das and CP867 Surajit Dutta were engaged in vehicle checking duty on Contai - Digha road at Mekeada Bye-pass more then I noticed one person riding one motor cycle coming towards Digha with a reckless speed. We tried to stop him through showing signal but he paid no heed at all. We also found that some person are totally afraid of in respect of the seeing the speed and manner of riding of the said vehicle which is a danger to the human life including the passers by. Fearing no other alternative we chased him and after few minutes we could managed to apprehend him, however he tried to escape away. After apprehension it was found the said person is in drinking condition and unable to drive any vehicle, so we brought him at Contai SD Hospital for his treatment where we confirmed from the attended M.O. that the said person within drinking condition, then I asked to show the relevant documents in respect of motor cycle bearing Regd. No - WB32A/7254 ample opportunity has been given him to produce the same but he did not comply the same till time.

Under the above circumstances I pray before your kindness that necessary legal action may kindly be taken against the above mentioned arrested accused as he committed offences u/s 279 IPC and 177/181/184/185/190(2) / 196 MV Act through lodging a F.I.R and obliged.
