
In producing herewith 02 (Two) arrested male accused persons namely (i) Sk Nurul Islam (54) S/O Lt. Sk Khalek Uddin of Khagraboni, P.O- Darua, P.S. Contai, Dist-Purba Medinipur and (ii) Habibur Rahaman(55) S/O Lt. Lutfar Rahaman of Darua P.S. Contai, Dist-Purba Medinipur in custody under proper Memo of Arrest with seized 20 (Twenty) bottles sealed country spirit (each 600 ml), duly signed by witnesses and accused persons. I ASI Bijoy Mitra of Contai PS do hereby lodged a complaint, to the effect that today (04.06.17) at 18:05 hrs. myself along with force holding special raid duty at Darua under Contai Municipality area, as per secret source information reached at Darua and held raid on a blue coloured TOTO styled as SODYCO and found that one Sk Nurul Islam (accused SI no-1) selling liquors amongst the public illegally on a TOTO Van and accused Habibur Rahaman (accused SI no-2) drive the said TOTO in a open place. On being asked they failed to produce any valid documents/license of the above mentioned possessed liquors. So the seller and driver are arrested.

Accordingly I have seized 20 bottles sealed country spirit (each 600 ml), after preparing seizure list duly signed by witnesses and accd person. I also prepared label and sample of seized articles.


