## Sub- F.I.R

Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Abul Khan, S/O- Lt. Mouladdin Khan of Vill: & P.O- Basantia, P.S-Contai, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 11.01.2017 at about 01.15 PM, I, Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO, both are of (S&LP), Contai Division Office, along with Sri Moumit Maji, AE & SM, Contai CCC, Sri Sukdeb Maity, LM Contai CCC others had been to the Vill: Basantia, P.S-Contai for routine inspection purpose. At first we went to the Domestic premises Abul Khan, S/O- Lt. Mouladdin Khan of Vill: & P.O- Basantia, P.S-Contai, Dist-Purba Medinipur and during inspection it was found that Abul Khan, S/O- Lt. Mouladdin Khan of Vill: Basantia, P.S-Contai, Dist-Purba Medinipur consuming electricity unauthorisedly by way of bypassing the energy meter by the way of tampering the incoming service cable in respect of Consumer Id No: 201764229, Meter No: L4781679, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of two core round shape black colour PVC coated tampered service cable (660/1100 volt grade 4 sq mm) of length two (2) meter (approx) along with bypass arrangement made by another two core round shape black colour PVC coated (660/1100 volt grade 4 sq mm) cable of length one (1) meter (approx) and one yellow card vide (Sl No: 2253021) in the name of Sri Abul khan were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:45 PM.

Thus Abul khan, S/O- Lt. Mouladdin Khan of Vill: & P.O- Basantia, P.S-Contai, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
