Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against **Sk Nurealam, S/O- Lt Sk Kalu of Vill: Paschim Bhawgabanpur, P.O- Darua, P.S-Contai, Dist-Purba Medinipur** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 07.06.2017 at about 1.00 pm, I, Sri Moumit Maji, A.E & SM Contai CCC, along with Sri Souvik Karar, O.E Contai CCC, Sri Pradip Kumar Nayek, TSH, Contai CCC had been went to the Vill: Paschim Bhawgabanpur, P.S-Contai for routine inspection purpose. At first we went to the premises of **Sk Nurealam, S/O- Lt Sk Kalu of Vill: Paschim Bhawgabanpur, P.O- Darua, P.S-Contai, Dist-Purba Medinipur** and during inspection it was found that **Sk Nurealam, S/O- Lt Sk Kalu of Vill: Paschim Bhawgabanpur, P.S-Contai, Dist-Purba Medinipur** is consuming electricity unauthorisedly by way of tampering the incoming service cable in respect of Consumer Id 223000820, Meter No EE725540, causing loss of revenue to WBSEDCL in the tune of load 3.00KVA.

As theft of electricity was detected during the inspection, the service connection was disconnected from pole and some portion of two core round shape black colour PVC coated tampered service cable (660/1100 volt grade 10 sq mm) of length 1.5 meter (approx) in the name of **Sk Nurealam** were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 1.30 PM.

Thus **Sk Nurealam, S/O- Lt Sk Kalu of Vill: Paschim Bhawgabanpur, P.O- Darua, P.S- Contai, Dist-Purba Medinipur** has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
