Sir,

In producing here with arrested alleged person namely Chandan Kumar Panda (33) S/o.- Ashutosh of Analberia, Ps. - Contai, Dist.- Purba Medinipur alongwith seized articles like- 12 bottles of Kingfisher Beer @ Rs100/- each, 19 bottles of Carlshbarg Beer @Rs120/ each, 15 bottles of King Fisher Blue Beer@Rs 120/- , 06 bottles of Mc Dowells No.1 Rum (180 ml)@ Rs 90/- & 06 bottles sealed Country spirit @ Rs.-65/- each, Total value of Rs.- 6210/-.

I, SI Swapan Goswami, presently posted at Contai Ps, do hereby lodged a complaint against Chandan Kumar Panda (33) S/o.- Ashutosh of Analberia, Ps. - Contai, Dist.- Purba Medinipur to the effect that today i.e on 09.06.17 in course of my night patrolling duty alongwith C/62 Biswanath Barui & C/1515 Amrit Ranjan Bar vide C.C No- 2162 dated 08.06.17, while going through the contai-Belda road at about 00.05 hrs. I received an information from my credible source that one person namely Chandan Kumar Panda (33) S/o.- Ashutosh of Analberia, Ps. - Contai, Dist.- Purba Medinipur was selling liquors at Panda Hotel & Dhaba under Contai PS. Accordingly, I inform to I/C Contai PS over phone and as per his direction myself along with forces entered Panda Hotel & Dhaba at Rautara under Contai PS at about 00:25 hrs. and found that said alleged selling Liquors from his Hotel cum Dhaba among the public illegally. Seeing the police persons several persons fled away. They I called two disinterested local persons and in presence of them I started searching the said Hotel cum Dhaba. On being searched I found 12 bottles of Kingfisher Beer @100/- each, 19 bottles of Carlshbarg Beer @120/ each, 15 bottles of King Fisher Blue Beer@ 120/- , 06 bottles of Mc Dowells No 1 Rum (180 ml)@ 90/- & 06 bottles sealed Country spirit @ Rs.-65/- each, Total value of Rs.- 6210/- in four cartoons (made of by Pitch board). On being asked, he could not produce any valid documents in favour of those liquors. There after, I seized the same under preparing proper seizure list duly signed by the witnesses. However ample opportunity has been given to produce the same but he did not produced any valid documents. Then I arrested him and during interrogation, it reveals that the alleged Chandan Kumar Panda (33) S/o.- Ashutosh of Analberia, Ps. - Contai, Dist.- Purba Medinipur was selling liquors from there since few years with illegal means.

Under the above fact and circumstances, I therefore pray before your kind self that a F.I.R may kindly be lodged against Chandan Kumar Panda (33) S/o.- Ashutosh of Analberia, Ps. - Contai, Dist.- Purba Medinipur as he committed offence U/S- 46(A) B.E. Act.
