In producing herewith the following seized articles I beg to submit that on 22.06.17 at 20:00 hrs. myself along with force C/1172 Mukunda Das and C/867 Surajit Dutta while performing evening Mobile Duty vide C.C. No.- 2346/17 dtd. 22.06.17 then received an information that one person namely Tarun Giri running illegal business of Country Spirit at Basudebberia. Accordingly I informed I.C Contai PS regarding the matter and as per his direction myself along with force transit towards Basudebberia to work out the information. On reaching over there I found one shop cum residence house situated at Basudebberia and some persons are there house premises, seeing the police persons the shopkeeper along with other 2/3 persons fled away then I asked the local people to be present and to assist us for searching of the shop cum residence house. I have searched the said shop cum residence house in presence of local witnesses and seized the following articles duly signed by the witnesses. On being asked it came to know that one Tarun Giri S/o.- Kunja Bihari Giri of Basudebberia, PS- Contai, Dist- Purba Medinipur used to run his illegal business through selling Country Spirit without having any valid license.
