Paresh Jana at village & P.O.: Namaldiha, P.S.: Contai, Dist: Purba Medinipur and Goutam Jana, S/O: Lt. Paresh Jana at village & P.O.: Namaldiha, P.S.: Contai, Dist: Purba Medinipur have committed theft of electricity U/S-135 of the Electricity Act-2003 read with amendment act-2007 is being stated hereunder.

On 23.06.2017 around 12:10 P.M. I, Subhendu Sarkar, A.E. & Station Manager of Marishda CCC along with Ashok Kumar Dohi, Hg. Sr. LM, Prasun Das, Office Executive, Nimai Das, Sr. TSH and Subhas Singh, TSH belong to Marishda CCC entered the domestic premises of Krishna Mohan Jana, S/O: Lt. Paresh Jana at village & P.O.: Namaldiha, P.S.: Contai, Dist: Purba Medinipur for routine inspection and found that Krishna Mohan Jana, S/O: Lt. Paresh Jana at village & P.O.: Namaldiha, P.S.: Contai, Dist: Purba Medinipur was consuming electricity dishonestly by the way of meter bypassing by tampering incoming service cable causing revenue loss of WBSEDCL at a tune of load 0.59 KVA. Consumer ID of said consumer is: 200580236.

As theft was detected during inspection that line has been disconnected from LT installation of WBSEDCL and some portion of one number two core black coated PVC cable (approx 1.5 ft. in length each) along with 1 no black coated single core PVC cable (approx. 0.5 ft. in length) were seized in presence of the members of inspection team. The seizure list was prepared in presence of inspection team and obtained signatures on the seizure list. The seized material duly packed and labeled. After completion of inspection the inspection team left the aforesaid premises around 12:25 P.M.

After this inspection around 12:30 P.M. I, Subhendu Sarkar, A.E. & Station Manager of Marishda CCC along with Ashok Kumar Dohi, Hg. Sr. LM, Prasun Das, Office Executive, Nimai Das, Sr. TSH and Subhas Singh, TSH belong to Marishda CCC entered the commercial fishery premises of Goutam Jana, S/O: Lt. Paresh Jana at village & P.O.: Namaldiha, P.S.: Contai, Dist: Purba Medinipur for routine inspection and found that Goutam Jana, S/O: Lt. Paresh Jana at village & P.O.: Namaldiha, P.S.: Contai, Dist: Purba Medinipur was consuming electricity dishonestly by the way of direct hooking from nearest installation of WBSEDCL causing huge revenue loss of WBSEDCL at a tune of load 0.7 KW.

As theft was detected during inspection that line has been disconnected from LT installation of WBSEDCL and some portion of one number two core black coated PVC cable (approx 1.5 ft. in length each) was seized in presence of the members of inspection team. The seizure list was prepared in presence of inspection team and obtained signatures on the seizure list. The seized material duly packed and labeled. After completion of inspection the inspection team left the aforesaid premises around 12:50 P.M.
