In producing herewith one arrested accused namely Ranjoy Yadav (27) S/o- Hari Yadav of Damachak, P.O.+PS.- Laxmipur, Dist.- Jamui, Bihar driver of the lorry bearing Regd. No. OD11E/1155 and all relevant paper in respect of arrest memo , seizure list including vehicle bearing Regd. No. OD11E/1155 before your kind self for taking necessary legal action. Today i.e on 01.07.17 at about 00:45 hrs. received telephonic information from duty officer of Contai PS that one vehicle bearing Regd. No. OD11E/1155 passing through Mechada Bye- pass with a reckless speed. Having said information along with force C/1142 Kalisankar Bera and C/1597 Bibekananda Mondal left for the work out that information. After reaching Khargapur Bye- Pass I tried to control the speed of said vehicle but driver of the vehicle violated our signal and passes with a heavy speed which may in danger for human life. Founding no other alternative we the patrolling party chased the said vehicle and ultimately managed to detain the vehicle and apprehended the accused driver.

Under the above circumstances I pray before your kind self that necessary legal action may kindly be taken against the above noted arrest accused as he committed offence U/S 279 IPC. and 184 M.V. Act.
