Sir,

I, SI Swapan Goswami of Contai PS beg to submit written complaint against 100/150 persons to the effect that on 03.07.2017 myself along with SI Madan Mohan Maity, ASI Uttam Bangal, LASI Ruma Mondal, C/824 Madan Das, C867 Surajit Dutta, C137 Hrishikesh Maikap, SAP C/528 Iktar Rahaman, C/ 724 Molay Ch. Mondal, LC/1800 Suparna Roy, LC/890 Mandira Maity were performing law & order duty in c/w procession of Puna Ratha Jatra (Ulto Rath) festival 2017 Darua to Mahishamunda side vide Contain PS Special C.C No-52/17 dated 03.07.17 & 53/17 dated- 03.07.17. At about 23:30 hrs. when the procession of Mahishamunda Rath reached near Jumma Masjid at Choto Darua under Contai PS then some unknown persons of muslim community raised voice against the loudspeaker and musical instrument which were using for the processions. The people of muslim community demanded to stop loud speaker as well as musical instruments over that place adjacent to that mosque. Heard that objection the persons of the procession of said Rath got annoyed and did not bother their demand and keep continuing their procession with loud speaker & musical instruments. Resulting a hot altercation along with scrupling started among the persons of both the Hindu & Muslim community, which leads to a chaotic situation. Due to that situation a total chaos and paniced environment was created. We the Police persons, who were performing duty trying utmost to stop them by various means. Then some unknown persons assaulted our police persons during that time resulting they received some minor injuries on their body. Some unknown persons took advantage of that situation and damaged our government vehicles vide bearing no. WB 32 K/5753, WB 29A/0555, WB 26C/7367 by pelting stones and brick batters. Later providing our best efforts we could manage to segregate both the communities at different sides of the Darua and Maisamunda road to control the mob. On a result the agitating mob of both sides became under control, however threatening from both sides were still continuing. Later separate police team reached at that place as enforcement. After getting re-enforcement founding no other alternative to maintain peace and tranquility at that place we dispersed the mob of both side creating trouble in that place by brandishing lathi. Then we could able to move that procession of Rath from that place and ultimately the processions along with Rath reached at Mahishamunda safely.

Under the fact & circumstances I pray before your good self that, the written complaint may kindly be treated as FIR against those unknown persons of both Hindu & Muslim communities who were involved to create breach of peace and violated peace & tranquility and also damaged the Govt. property like vehicles vide bearing no. WB 32 K/5753, WB 29A/0555, WB 26C/7367 and obstructed the police team to discharge their Govt. duty as well kindly take appropriate legal action and oblige.
