In producing herewith 01 (one) arrested male accused person namely Amar Pradhan S/o. Madan Mohan Pradhan of Saria, P.O.- Raipur Paschimbar, P.S. Contai, Dist. Purba Medinipur in custody under proper Memo of Arrest with seized 05 bottles sealed country spirit(each 600 ml) duly signed by witnesses and accused person . I ASI Sagar Bera of Contai PS do hereby lodge a complaint, to the effect that today (28.01.17) at 18:55 hrs myself along with force holding special raid duty at Saria under Contai PS area. As per secret source information reached at village Saria and held raid. I found that one Amar Pradhan S/o. Madan Mohan Pradhan of Saria, P.O. - Raipur Paschimbar, P.S. Contai, Dist. Purba Medinipur is selling Country Spirit illegally in his shop. On being asked he failed to produce any valid documents / license of the above mentioned possessed country spirit. So the seller is arrested.

Accordingly I have seized 05 bottles sealed country spirit after preparing seizure list duly signed by witnesses and accd. person. I also prepared label and sample of seized articles.

So, I pray that a case has been started against the arrested accused person Amar Pradhan S/o. Madan Mohan Pradhan of Saria, P.O.- Raipur Paschimbar, P.S. Contai, Dist. Purba Medinipur U/S 46 (A) B.E. Act and arrange for its investigation.
