In producing herewith 01 (one) arrested male accused person namely Makhan Gayen (51) S/o.- Lt. Accordingly I have seized 12(Twelve) bottles sealed country spirit, (each bottle Rs. 65/-) after preparing proper seizure list duly singed by witnesses and accused person. I also prepared label and sample of seized articles.

So I pray that a case has been started against above noted arrested accused person U/S 46 (A) of B.E. Act and arrange for its investigation.
