
In producing herewith 01 (one) arrested male accused person namely Makhan Gayen (51) S/o.- Lt. Nirmal Gayen of Dharmadasbarh, PS- Contai, Dist.- Purba Medinipur in custody under proper Memo of Arrest with seized 12(Twelve) bottles sealed country spirit along with all connective papers. I SI Soumya Paul of Contai PS do hereby lodge a complaint, to the effect that today (08.02.2017) at 05:15hrs myself along with force of Contai PS, was holding special raid duty under Contai PS area. As per secret source information myself along with force reached at Dharmadasbarh (Near Tripti Cinema Hall) , and held raid in the shop of above noted accused person and found that the above noted accused person is selling Country Spirit amongst Public illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed country spirits. So the above noted seller is arrested.

Accordingly I have seized 12(Twelve) bottles sealed country spirit, (each bottle Rs. 65/-) after preparing proper seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

So I pray that a case has been started against above noted arrested accused person U/S 46 (A) of B.E. Act and arrange for its investigation.
