In producing herewith arrested alleged person namely Sk Najrul @ Islam (32) S/o- Lt. Sk. Mantu of Uttar Darua, Ps.- Contai Dist.- Purba Medinipur with 10 bottles Foreign Liquors containing (i) 04 bottles sealed Officers Choice contains 375 ml/bottle @ Rs.-200/- each (ii) 06 bottles sealed Mc Dowell's XXX Rum contains 180 ml/bottle @ Rs.-90/- each & 06 bottles sealed Country spirit @ Rs.-60/- each, Total value Rs.-1700/-

I, SI Tarun Kumar Sadhukhan, presently posted at Contai Ps. do hereby lodged complaint as Suo-moto to the effect that today on 13.02.17 in course of my evening raid program with C/1084 Dasaarath Hembram & C/1172 Mukunda Das under Ps. area, at about 20:25 hrs. I received a telephonic information from reliable sources that one person namely Sk Najrul @ Islam (32) S/o. Lt. Sk Mantu of Uttar Darua, Ps.- Contai Dist.- Purba Medinipur was selling liquors near Uttar Darua area under Contai Ps. since few years.

Accordingly, I inform to I/C Contai Ps. and as per his direction myself along with force reached at Uttar Darua under Contai Ps. at about 21:05 hrs. and found that said alleged selling Liquors among the public illegally. On being searched, 16 bottles sealed Foreign Liquor & Country Spirit in one nylon bag were recovered from his possession. On being asked, he could not produce any valid documents in favour of those liquors. There after, I seized the same under proper seizure list duly signed by the witnesses. I arrested him and during interrogation, it reveals that the alleged Sk Najrul @ Islam(32) was selling liquors from there since few years.

Under the above fact and circumstances, I therefore pray that a case may kindly be started U/S- 46(A) B.E. Act. against said Sk N. jrul @ Islam(32) S/o. Lt. Sk Mantu of Uttar Darua, Ps.- Contai Dist.- Purba Medinipur
