I do hereby lodge a complaint empowered by the Electricity Act 2003 read with amendment act 2007 to the effect that Dibyakesh Giri, S/O: Lt. Bankim Giri at village: Amtalia, P.S.: Contai, Dist: Purba Medinipur has committed theft of electricity U/S 135 of the Electricity Act 2003 read with amendment act-2007 is being stated hereunder.

On 07.03.2017 around 12:30 P.M. I, Subhendu Sarkar, A.E & Station Manager of Marishda CCC along with Snehasish Kharua, Sr. SAE, Prasun Das, O.E, Tapan Kr. Das, Hg. Sr.LM, and Subhas Singh, TSH belong to Marishda CCC entered the domestic premises of Dibyakesh Giri, S/O: Lt. Bankim Giri at village: Amtalia, P.S.: Contai, Dist: Purba Medinipur for routine inspection and found that Dibyakesh Giri, S/O: Lt. Bankim Giri at village: Amtalia, P.S.: Contai, Dist: Purba Medinipur was consuming electricity dishonestly by the way of meter bypassing for less recording of meter causing revenue loss of WBSEDL at a tune of load 1 KW. At that premises there is a connection vide consumer ID is: 200592635

As theft was detected during inspection that line has been disconnected from LT installation of WBSEDL and some portion of 2 nos. single core red coated PVC cable which was used for meter bypassing were seized in presence of the members of inspection team. The seizure list was prepared in presence of inspection team and obtained signatures on the seizure list. The seized material duly packed and labeled. After completion of inspection the inspection team left the aforesaid premises around 12:45 P.M.

Thus Dibyakesh Giri, S/O: Lt. Bankim Giri at village: Amtalia, P.S.: Contai, Dist: Purba Medinipur have committed theft of electricity U/S - 135 (i)(b) of the Electricity Act 2003 read with amendment act 2007.

You are, therefore, requested to take cognizance of this offence for this complaint and treat it as F.I.R.
