Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Pratap Chandra Maity, S/O - Lt. Sashibhusan Maity, a permanent resident of Vill-Dholmari, P.O -Dholmari, P.S -contai, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 07.03.2017 at about 2.30 PM I, Sri Moumit Maji, A.E & SM Contai CCC along with Sri Swapan Kumar Mondal, Higher Grade TSH, Sri Souvik Karar, O.E Contai CCC had been to the village Dholmari for routine inspection purpose. During inspection it was found that Sri Pratap Chandra Maity was consuming electricity dishonestly in his Agricultural premises consuming electricity unauthorisedly by way of direct hooking from LT bushing of transformer of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 4.38 KVA.

As theft of electricity was detected during inspection Some portion of 3(Three) core black colour PVC coated cable of length 2(two) meter approx and another single core blue colour PVC coated cable used for neutral of length 2(two) meter approx were seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Pratap Chandra Maity acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 3.30 PM.

Thus the accused Sri Pratap Chandra Maity, S/O - Lt. Sashibhusan Maity, Vill - Dholmari, P.O -Dholmari, , P.S -contai, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain & treat it as FIR.
