In producing herewith one arrested accused person namely 1) Kesab Payra (31) S/O- Susanta Payra of Village Purba Badalpur PS Contai Dist Purba Medinipur with seized articles 1) Eight (08) Bottles Sun Fighter Spirit Country Spirit (each 600M L) each Rs 65 total value Rs 520 under proper seizure list from the possession of arrested person. I, S.I Tapan Kumar Parta of Contai PS do hereby lodged complaint to the effect that on 22.03.2017 at 19.45 hrs while myself along with Const.980 Goutam Kar, Const 542 Nupur Maity was performing mobile duty vide Contai PS P.S. C.C.No-1060/2017 dt. 22.03.2017 & received a source information that one persons is selling Country Spirit in his shop at Pichabani, under Contai PS. After receiving such information I informed to In Charge Contai PS, about the matter and as per his order myself along with force reached at Pichabani, under Contai PS at 20.05 hrs. and found that one (01) person is selling Country Spirit from his shop situated at Pichabani, under Contai PS to the peoples and passersby. But on getting scent the arrival of police said Country Spirit seller tried to flee away. But we could manage and able to apprehend one persons namely 1) Kesab Payra (31) S/O- Susanta Payra of Village Purba Badalpur PS Contai Dist Purba Medinipur. On interrogation he confessed his guilt and disclosed his identity as the owner of Country Spirit selling Shop. Accordingly we searched and found <sup>eight</sup> ~~eight~~ (08) Bottles Sun Fighter Spirit Country Spirit (each 600M L) is lying in his Shop. On being asked he disclosed above noted identity and on demand he failed to produce any valid license/documents/ challan in supports of such possession and selling of Country Spirit. Accordingly I arrested him & seized the above noted articles after preparing proper seizure list duly signed by the witnesses and took sample <sup>two</sup> ~~one~~ bottles Sun Fighter Spirit Country Spirit as Sampale from seized articles and labeled also. I arrested the above noted accused person issued memo of arrest and also inform them ground of arrest. On interrogation the arrested 1) Kesab Payra (31) S/O- Susanta Payra of Village Purba Badalpur PS Contai Dist Purba Medinipur stated that he is the seller Country Spirit, It is evident and crystal clear that the arrested accused person are seller of Country Spirit violating provision of section 46A of Bengal Excise act. 1909. It is also revealed during enquiry that the said arrested person are selling the Country Spirit to the public.

Under the above fact and Circumstances I pray before you that a specific case may kindly be started against the accused persons namely 1) Kesab Payra (31) S/O- Susanta Payra of Village Purba Badalpur PS Contai Dist Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
