I

(ii) Asok Kr. Ghosh of Digha PS do hereby lodge a complaint as suo - moto after returning at PS to the effect that today (23.04.17) at about 14.15 hrs myself along with C/790 Tapan Kr. Panda

I Kevnick. Kole all of Digha PS vide C.C. No. 538 Dt.23.04.17 as per secret source information that one Ranjan @ Sarjen Hera and Samarendra @ Mohan Das Mahapatra selling Country Sprit, Beer, & Foreign Liquor illegally. On getting information rush to the Digha Border and holding raid & search in the tea stall and found huge quantity of country sprite, Beer & Foreign Liquor store in his tea stall illegally selling to the public in lieu of money. On being asked above noted accused person failed to produce any valid documents / license of the above mentioned possessed liquor and disclosed his name and address. Accordingly I have seized the following County Sprit, Beer & Foreign Liquor illegally as per seizure list properly duly singed by witnesses. I have arrested the above noted accused person but one Ranjan @ Sarjen Hera seeing Police he run away to avoid Police arrest and also he selling since long of the above noted articles and he is the owner of the stall. Thereafter issued arrest Memo & explain his ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

Accordingly I seized the following (i) County Sprit-20 bottles X 65/- = 1300/-, (ii) Pinkan Kingla No 1-10 Bottles X 65=650/- (iii) Forster Gold Strong Beer-25 Bottles X 100/- = 2500/- (iv) Thuring Strong Beer - 20 Bottles X 90/- = 1800/- (v) McDowell 375 ml 6 Bottles X 180/- = 1080/- (vi) McDonell 180 ml 20 Bottles X 90=1800/- total value of Rs-9130/- (Nine Thousands One hundred thirty only) Liquor as per seizure list duly singed by witnesses I arrested the above noted accused person and explain his ground arrest and took his signature in the arrest Memo and seizure list. He also prepared label and sample of seized articles.

During local enquiry it could be learnt that the above noted accused persons selling illegally above noted seized articles since long.

So I do hereby lodge a written complaint as suo-moto against above mentioned accused persons @ Mohan Das Mahapatra [46] S/O Lt. Dinanath Das Mahapatra of Bajitpur, P.S-Talsari Marin P.S, District-Balasore (Odisha) and Ranjan @ Sarjen Hera [42] S/O Lt. Manmotha of Bajitpur P.S Digha, Dist. Purba Medinipur for violation u/s-46(A) of Bengal Excise Act, 1909 requesting O/C Digha P.S for starting a case.
