In producing herewith 01 (One) arrested male accused person Namely Srikanta Barik [37] S/O Lt. Murari Mohan Barik of Duttapur, P.S-Digha, District-Purba Medinipur arrested S.I Asok Kumar Ghosh Dt.05.05.17 in custody under proper Memo of Arrest of seized Country Sprit as per seizure list duly signed by witnesses. I SI Asok Kr. Ghosh of Digha PS do hereby lodge a complaint as suo - moto after returning at P.S to the effect that today (05.05.17) at about 19.30 hrs myself along with C/1171 Salil Banerjee and C/1137 Kajal Parui all of Digha P.S vide G.D.E No.167 Dt.05.05.17 as per secret source information reached at Duttapur holding raid & search in the Ghumti and found huge quantity of country sprite store in his ghumti illegally to the public in lieu of money. On being asked the above noted accused person failed to produce any valid documents / license of the above mentioned possessed liquor and disclosed his name and address. Accordingly I have seized the following County Sprit as per seizure list properly & duly signed by witnesses. I have arrested the above noted accused person & issued arrest Memo & explain his ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused persons illegally selling Country sprit since long. So I seized following articles 12 bottle Country Sprit (Sun Nark ) 600 ml per bottle Rs 65 X 12 = 780/- (Seven hundreds Eight only)

So I do hereby lodge a written complaint as suo-moto against above mentioned accused Srikanta Barik [37] S/O Lt. Murari Mohan Barik of Duttapur, P.S-Digha, District-Purba Medinipur for violation u/s-46(A) of Bengal Excise Act. -1909 requesting O/C Digha PS for starting a case.
