I A.S.I Milan.Doloi of Digha P.S. do hereby lodge a complain as suo - moto after returning at P.S. to the effect that today (06/06/17) at about 19.25 hrs myself along with C/790 Tapan Kr Panda NVF1667 Sk. Habibur Md. all of Digha P.S vide C.C. No-831 dt-06/06/17 as per secret source information reached at New Digha Jhow Jungle and holding raid in the Pan stall owner of Srimanta Mahakur. He is selling country sprit, on being asked the above noted accused person failed to produce any valid documents/license.and disclosed his name and address being asked he stated that he is selling country sprit since long time

Accordingly I have seized the following country sprit as per seizure list properly duly signed by witnesses. I have arrested the above noted accused person and during arrest asked him ground arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused person illegally selling country sprit since long time I seized 15 (Fifteen) bottle country sprit (SUN Mark) per bottle 600 ML total liquor (600\*15) 9000 M.L. Total value of Rs- (65\*15) Rs 975/- (Nine hundred Seventy Five) only. With one Nylon bag.

So I do hereby lodge a written complain as suo-moto against above mentioned accused Srimanta Mahakur [30] S/O Lt. Gayaprasad of Duttapur PS Digha Dist-Purba Medinipur owner of Pan stall for violation U/S -46(A) of Bengal Excise Act.-1909 requesting O/C Digha PS for starting a case.
