Sir,

In producing herewith 01 (One) arrested male accused person Namely Rabi Senapati @ Bimal (28) S/O Ardhendu Senapati of Kankaswar, P.S- Ramnagar, District Purba Medinipur arrested by A.S.I Milan Doloi Dt.12.01.2017 in custody under proper Memo of Arrest of seized Country Spirit as per seizure list duly signed by witnesses. I A.S.I Milan Doloi of Digha P.S. do hereby lodge a complaint as suo - moto after returning at P.S. to the effect that today (12.01.2017) at about 18.25 hrs. myself along with C/1171 Salil Banerjee, C/1137 Kajal Parui, all of Digha P.S. vide GDE No.294 and C.C. No- 110/17 dt-12.01.2017 as per secret source information reached at Old Digha Jhau Jangle and held raid and found he is selling Country Spirit illegally. On being asked the above noted accused person failed to produce any valid documents / license of the above mentioned possessed liquor and disclosed his name and address before me and he confessed that he is selling liquor illegally since long in lieu of money to the public.

Accordingly I seized the 15 bottles Country Spirit (Sun Mark) per bottle 600 Ml. total liquor 15X600=9000 Ml. total value of rupees 15X65=975/- as per seizure list duly signed by the witnesses and also arrested the above noted accused person and explain his ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused person illegally selling Country spirit since long. So I seized following articles (i) 15 bottle Country Spirit (Sun Mark) 600 Ml. X 15 = 9000 ml. per bottle Rs. 65 X 15 = 975/- (Nine Hundred Seventy five only) in which one bottle as sample.

So I do hereby lodge a written complaint as suo-moto against above mentioned accused Rabi Senapati @ Bimal for violation u/s-46(A) of Bengal Excise Act.-1909 requesting O/C Digha PS for starting a case.
