Sir,

In producing herewith 01 (One) Dipak Pradhan (25) S/O Amalendu Pradhan of Lachimpur, P.S. Ramnagar, District Purba Medinipur arrested on dt.30.01.2017 in custody under proper Memo of Arrest of seized Country Spirit as per seizure list duly signed by witnesses. I SI Ashok Kr. Ghosh of Digha PS do hereby lodge a complaint as suo - moto after returning at P.S to the effect that today (30.01.2017) at about 20.35 hrs myself along with C/851 Sundar Mandi, NVF/1667 Sk Habubur Mahammed all of Digha P.S vide C.C. No.222/17 Dt.30.01.2017 as per secret source information reached at Paschim Godadharpur and held raid in the Tea stall of above noted person and found he is selling Country Spirit illegally. On being asked the above noted accused person failed to produce any valid documents / license of the above mentioned possessed liquor and disclosed his name and address before me and he confessed that he is selling liquor illegally since long in lieu of money to the public.

Accordingly I seized the 10 bottles Country Spirit as per seizure list duly signed by the witnesses and also arrested the above noted accused person and explain his ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused person illegally selling Country spirit since long. So I seized following articles (i) 10 bottle Country Spirit (Sun Mark) 600 ml X 10 = 6000 ml. per bottle Rs. 65 X 10 = 650/- (Six Hundred fifty) in which two bottle as sample.

So I do hereby lodge a written complaint as suo-moto before O/C Digha P.S against above mentioned accused namely Dipak Pradhan (25) S/O Amalendu Pradhan of Lachimpur, P.S. Ramnagar, District Purba Medinipur for violation u/s-46(A) of Bengal Excise Act.-1909 requesting O/C Digha PS for starting a case.
