producing herewith 01 (One) arrested male accused person Namely Purna Bera [25] S/O Khogendra Nath Bera of Duttapur Colony, P.S-Digha, District Purba Medinipur arrested S.I Asok Kumar Ghosh Dt.28.03.17 in custody under proper Memo of Arrest of seized Country Sprit & Bear as per seizure list duly signed by witnesses. I SI Asok Kr.. Ghosh of Digha PS do hereby lodge a complaint as suo - moto after returning at PS to the effect that today (28.03.17) at about 19.15 hrs myself along with C/313 Manik Mahato C/908 Santi Ranjan Dey, all of Digha-P.S vide C.C. No.1411 Dt.28.03.17 as per secret source information reached at Duttapur holding raid & search in the Ghumti and found huge quantity of country sprit & Bear store in his ghumti illegally to the public in lieu of money. On being asked the above noted accused person failed to produce any valid documents / license of the above mentioned possessed liquor and disclosed his name and address. Accordingly I have seized the following County Sprit & Bear illegally as per seizure list properly duly signed by witnesses. I have arrested the above noted accused person & issued arrest Memo & explain his ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

Accordingly I seized the following Country Sprit & Bera as per seizure list duly signed by witnesses said officer arrested the above noted accused person and explain his ground arrest and took his signature in the arrest Memo and seizure list. He also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused persons illegally selling Country sprit & Bear since long. So the officer seized following articles (i) 06 bottle Country Sprit (Sun Nark) 600 ml per bottle Rs 55 X 6 = 330/- (ii) 06 Bear (Toubarg) 650 ml per bottle Rs 100 X 06 = 600/- total value of Rs 930 (Nine hundrade thirty only)

So I do hereby lodge a written complaint as suo-moto against above mentioned accused Purna Bera [25] S/O Khogen Bera of Duttapur P.S-Digha, District-Purba Medinipur for violation u/s-46(A) of Bengal Excise Act.-1909 requesting O/C Digha PS for starting a case.
