We are writing to make a formal complaint against the service of Anapol Security & Secret Services. It was noticed during our daily morning site visit on 01.01.2017 that part of spare cable of charging car was stolen from the cable drum that was kept inside the plant. Please note that this is the second instance in 4 months.

We cannot use the left out cable for our equipment. This has to be procured as one lot without joints. Cost of one drum cable is Rs. 8, 50,000 + taxes which will be deducted from your monthly bills.

This is serious concern of security lapse which we have witnessed here which is hampering our business compromising our plant and machineries. You may be very well aware that acts like these will lead to termination of contract and collection of compensation.
