Dear Sir,

I, Tufan Pati, S/o Sanjib Pati of Gram Durbaberia, Post Taj Nagar under Sutahata Police station, am driver of a Lorry working under PIONEER MINERAL PVT LTD, Durgachak, Haldia.

Today I was driving truck no WB29-2731 and was going to M/s Hindustan Unilever factory. Just 50 meters before HUL gate, I meet with an accident with a motor bike No. WB30T 6438.

The bike driver did not get any sort of injury and I offered to repair the small damages to the bike.

The riders, whom I know are Security guards at M/s Hindustan Petroleum (HPCL), Tank terminal and their names are : **1. Prodyut Kumar Das**, S/O Pulin Behari Das, Vill : Chhotoudaypur, PO : Argoal, Purba Medinipur & **2. Chandra Sekhar Biswas**, S/O Dulal Krishna Biswas, Vill : Palasi, Tehatta, Nadia, along with other security guards present at the factory gate, started beating me and took away the Lorry Keys, Lorry registration original papers and Rs. 22000/- in cash which was kept inside the lorry drawer and went inside HPCL Main Gate.

I informed my company and the petrolling Police Van. The Police were also not allowed to enter HPCL by the same security Guards and we were abused by foul language.

I request you to please look into the matter and kindly arrange to recover the Trucks Original Registration papers and the Cash.
