Sub: Prayer to lodge FIR

Sir,

In producing here with the following 04 (Four) arrested accused persons namely 1. Animesh Jana (28 Yrs), S/O- Sripati Jana of Chaitanyapur, PS.- Sutahata, Dist.- Purba Medinipur, 2. Suvendu Manna (29 Yrs) S/O- Sisir Manna of Krishnanagar, PS.- Khejuri, Dist.- Purba Medinipur, 3. Ashani Patra (29 Yrs), S/O- Amlayan @ Amlan Patra of Vill.- Tangramari, PS.- Khejuri, Dist.- Purba Medinipur, 4. Arijit Samanta (28 Yrs), S/O Subai @ Tarit Samanta of Vill.- Khagda, PS.- Chandipur, Dist.- Purba Medinipur under arrest, I S.I. Raju Kundu of Durgachak P.S beg to report that on 18.06.2017 at about 00:05 hrs while I was performing night mobile duty under Durgachak PS area with C/765 Sanat Das, C/1338 Alok Chalak CV Soumitra Jana and GP Sukhendu Mondal all of Durgachak PS vide Durgachak PS CC NO. 2264/17 dt. 17.06.17 & GDE No.- 740, Dt. 17.06.17, received information from the duty officer ASI Dilip Mondal that some persons were creating public nuisance/halla near Manjushree More under Durgachak PS.

Accordingly at about 00.25 hrs we reached the place and found that the above noted persons were using slang languages towards our C/982 Tapan Kr. Dey and other Civic Volunteers who were performing their duties at Manjushree more. Looking this I asked the C/982 Tapan Kr. Dey about the matter and it could be learn that the above noted accused persons were creating public nuisance/halla at that place and when they tried to stop them the accused persons assaulted on duty Green Police namely Kishore Kr. Das, S/O- Hrishikesh Das of Vill.- Purba Raghunathchak, PS.- Durgachak, Dist.- Purba Medinipur by fist and blows, resulting he received injury on his person. Knowing this I tried to arrest them but that time they threatened me and my team and abusing with filthy languages and tried to discharge from our Govt. duties, on being hot chase they assaulted me by fist and blows resulting myself received injury. After that myself along with force able to arrest them for their act and explained them the cause of arrest and informed their relatives. I prepared memo of arrest and produce them before EMO at Haldia SD Hospital for routine medical check up. Also we (Injured Persons) treated before EMO at Haldia SD Hospital.

I along with force and arrested persons left for Durgachak PS and produced them before the in-charge of PS, SI Sankar Kr. Das with a prayer for starting a specific case against the above noted arrested accused persons as per law and arrange for its investigation.
