Sir,

In producing herewith one arrested accused namely **Smt. Durga Mondal (F/35 Yrs), W/O- Uttam Mondal of Vill.- Kumarchak, PS.- Durgachak, Dist.- Purba Medinipur**, along with the below noted seized items I, SI Raju Kundu of Durgachak PS beg to state that on 23.06.17 at about 14:45 hrs when I was performing my official work at Durgachak PS, received a credible source information that one person is running a business of selling of liquors without any license at Kumarchak under Durgachak PS. Accordingly, I consulted with O/C Durgachak PS and as per his direction left for the P.O. to work out the information accompanied by the evening mobile duty officer ASI Uttam Pandit, C/869 Manik Baskey, LCV Gouri Manik, CV Soumitra Jana, CV Sukhendu Mondal vide Durgachak PS C.C. No.- 2318/17, Dt. 23.06.17 & Durgachak PS GDE No. 916, Dt. 23.06.17. When we reached at Kumarchak, house of the accused person it could be found that the accused person was selling liquors to different customers. On seeing us they tried to run away but we managed to apprehend the above mentioned accused person with the help of LCV Gouri Manik who was selling liquors to different customers. On asking she disclosed her name as above. On search at her house the below noted I/D liquors were found. On enquiry it was known that she was conducting the business of selling of I/D liquors with-out any license since last few days. On demand she failed to produce any license for stock and selling of the liquors and any paper regarding possession of such quantity of liquors. So the below noted quantity of I/D liquors were seized from her house under proper seizure list in between 15:15 hrs to 15:45 hrs.

Description of the seized items:-

1. Total 08 Lts. I/D liquor contained in 04 pieces plastic bottles.

I also took 375 ml of seized liquor in one bottle from the above mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909 by the accused Smt. Durga Mondal (F/35 Yrs), W/O- Uttam Mondal of Vill.- Kumarchak, PS.- Durgachak, Dist.- Purba Medinipur. So I arrested the accused at 15:55 hrs with issuing proper arrest memo and maintain all hazat rules in presence of LCV Gouri Manik.

So, I pray before you, kindly start a case against the above noted arrested accused person under proper section of law and arrange for its investigation.
