I, S.I. Amit Deb, O/C Durgachak PS do hereby lodge a written complaint to the effect that on today (28.06.17) morning at 06:45hrs received an information from an unknown voice over telephone that and one Kabir Ali Beg has stored a huge quantity of iron scrap in a godown owned by Kabir Ali Beg s/o Lt. Joynal Beg situated at Banewarchak, under Joynagar GP, PS Durgachak storing it from different factories under Durgachak PS. He disclosed nothing more and he needed police interference. I noted it into the GD entry vide Durgachak PS GDE No.1093 dt.28.06.17 and I informed my superiors listen to their kind instruction then myself along with A.S.I Uttam Pandit, A.S.I. Dilip Mondal, C/982 Tapan Kr. Dey and C/869 Manik Kr. Baskey left for Banewarchak in order to point out the source information.

At 07:25hrs we could reached at Banewarchak in front of the godown of Kabir Ali Beg and found that on seeing police said Kabir Ali Beg try to council himself, and on being chase we could intercepting and found that huge quantity of iron scrape has been stored in his godown. On being question he failed to produce any valid documents/ Challan/ receipt in support such possession of huge quantity of iron scrap. He also failed to give any satisfactory account in support of possession of such huge quantity of scrap. Moreover he gave deferent statement in different time.

During local inquiry and on perusal various document it could be ascertained that the said Kabir Ali Beg stored huge quantity of iron scrap by stealing from various factories under Durgachak PS area and running such clandestine business of purchasing / storing /trading of such iron scrap since 8/9 month back co-operation with some others. So he is liable u/s 379/411 /413/414 IPC.

I took him into custody. Arrest was effected by issuing memo of arrest. I seized approx 15qtn.(fifteen quintal) of iron scrap comprising pieces of iron bar, iron rod, iron pipe etc. from his godown as SR properties under proper seizure list in presence of witnesses duly signed by them. I measure the seized iron scrap with the help of measuring balance which was seized as alamt.

On returned to the PS I started Durgachak PS case No.108/17 dt.28.06.17 u/s 379/411/413/414 IPC against Kabir Ali Beg (38yrs.) s/o Lt. Joynal Beg of Banewarchak, under Joynagar G.P, PS Durgachak, Dist. Purba Medinipur as suo-moto, took all informative actions, S.I. Raju Kundu will please investigate the case.
