Sir,

In producing herewith arrested accused namely Purna Pramanik (42 yrs), S/O Chittya Ranjan Pramanik of Kasberiya PS Bhabanipur (seller of illegal ID liquor) along with following seized articles as per seizure list I, ASI Uttam Kr. Pandit of Durgachak P.S. Dist. Purba Medinipur do here by lodged complaint against Purna Pramanik (42 yrs), S/O Chittya Ranjan Pramanik of Kasberiya PS Bhabanipur to the effect that on 07.07.17 myself along with C/ 704 Debaprasad Pattanayek left PS to perform morning mobile duty at PS area vide Durgachak PS GDE No.261dt.07.07.17 and C.C.No.2502/17 dt.07.07.17, in course of my morning mobile duty on 07.07.17 at about 08:15hrs. received source information that one person is coming from Kasberiya side by riding a bycycle for selling ID liquor illegally to the local public and younger's for gain in exchange of money. The such information informed to O/c Durgachak PS and duty office SI Saumya Paul. The information was diarized vide Durgachak PS GDE No.262 dt.07.07.17. After that as per direction of O/C Durgachak PS myself along with force weating at Basudebpur to work out the such information. After a few minutes as identified by my source that one person coming from Kosberiya side by riding by cycle carrying with one nylon bag with one bladder. Accordingly I stopped him and searched him and found that he carrying ID liquor for selling at deferent shop and I managed to intercepted the above noted person. On interrogation at spot he failed to produce any valid documents and license of the said ID liquor also failed to give any satisfactory answer to me in respect of ID liquor. Accordingly I interrogated him and he gave his above noted identity and stated that he is seller of illegal ID liquor, I recoded his statement u/s 161 Cr.P.C, prepared memo of arrest and arrested him. I seized the following articles as alamat from the possession of the arrested accd. Purna Pramanik (42 yrs), S/O Chittya Ranjan Pramanik of Kasberiya PS Bhabanipur with proper seizure list duly signed by the witnesses and taken one bottle ID liquor as sample from seized articles.

The list of seized articles as per seizure list which has been seized as alamat.

1. One old and use bycycle styled as "HERO"
2. One old and used nylon bag (green and yellow).
3. One yellow colour bladder containing 22 (twenty two) Lts of ID liquor, Total value of Rs. 100 x 22 = Rs.2200/-

Under the above facts and circumstances I pray you to start a specific case against the arrested person namely Purna Pramanik (42 yrs), S/O Chittya Ranjan Pramanik of Kasberiya PS Bhabanipur., Dist. Purba Medinipuras per law and arrange for its investigation.
